At the completion of this workshop students will:

- Define the basic rules of MLA and APA style citations.
- Develop in-text and bibliographic citations.
- Select appropriate citations in library databases.

What are citations?

Citations give credit to materials you use in your writing and tells readers where they can find sources. Books, journals, websites, or sources that are not your own thoughts must be given credit.

Why do researchers use citations?

Researchers use citations because it adds strength and authority to their writing.
Citations...

- Give credit & avoid plagiarism
- Place your work in a specific context
- Leave a trail that other scholars can use

What information should be cited?

Any information you include in your essay that...

- Are facts, figures, ideas, or information that is not common knowledge (this could be paraphrased material)
- Ideas, words, theories, or exact language that another person used such as in a book, book chapter, article, web page, theses, etc. (this could be paraphrased material)
- Direct quotations

If you are uncertain, cite the source in order to avoid plagiarism.

Paraphrased vs.
Direct quotes vs.
summarizing

Paraphrase: Maintains your own voice, while sharing important points from a source. Should be in your own words.

Quote: Maintains accuracy to the specific words of the author.

Summary: Relays main ideas from someone's writing.

Citation Tools

The library's OneSearch discovery system as well as the databases the library subscribes to all have tools to help you create citations in the correct format.


Even when using the citation tools available, you need to make sure the spacing and formatting is correct.

The following slides will show where to find these tools and how to use them.

One Search

One Search can make creating bibliographic citations easy!

First, begin by searching for a book or article you want to use.



Identifying Source Types

- Once you have a list of results, it's important to be able to identify the types of sources you're seeing.
- **One Search** indicates if the source is a book, article, video, etc.

Reading Citations

- Being able to read the citation is a helpful skill to determine the type of source you're looking at.
- If you're trying to locate sources in a reference list for further research, the first step is to know if you're looking for a book, article, video, etc.
- Being able to decode citations make this easier.

Citation Clues


- Titles of books are italicized
- Titles of journals/publications are italicized
- Titles of articles are in quotation marks




Citation Tool in OneSearch

Selecting a source will show you various tools that can help you.

One of these tools is a “citation” tool.

You can copy this citation and use this in your paper.

When you copy and paste the citation into your paper, make sure the spacing and indentation is correct. Different computers and browsers will paste it differently.







When you click on the Cite link, scroll through the box in the middle to find the right format, such as MLA.

Citation Format



Opposing Viewpoints Citation

Once you click on the Cite tool, you'll then see a box with several citation formats to choose from.

Creating the Works Cited page

- So far, we have seen a few examples of where to find the citation tool in the library's resources
 - OneSearch
 - Ebsco
 - Opposing Viewpoints
- Once you have copy and pasted all of your citations into one page, you can begin the process of putting the final formatting touches on.

Works Cited Page Tips

- Make sure the entire page is double spaced.
- Make sure that each citation is left-aligned and has a hanging indent.
- Make sure all of the sources are in alphabetical order.
- Make sure all of the font styles, sizes, and colors match.
- Once you have created your Works Cited page, it's much easier to create in-text/parenthetical citations.

Difference between in-text citations and Bibliography/Works Cited

In-text Citations

These are found at the end of a sentence and will have a matching reference at the end of your paper. This will look different, depending on which citation style you are using.

Bibliography/Works Cited

This is also called a reference page. Your reference page appears at the end of your work and provides more details regarding sources you used throughout your paper.

MLA and APA: In-text citations

The in-text citation starts with the same text that the citation is alphabetized by.

Both MLA and APA ask you to use the author-page method of citing.

Note: If you use the page number of author in your sentence, then you do not need to include this in the citation. However, if your sentence does not utilize either an author or page, both **MUST** be included.

Bibliography/Works Cited Page

Be sure that your
Bibliography or
Works Cited page is
always in
alphabetical order.
